Day 1: Wednesday, August 11, 2027 Fairbanks, Alaska

Most flights arrive into Fairbanks very late at night followed by an early morning the next day.

For air-inclusive reservations, the name provided at time of booking must match your government-issued ID that will be used during travel. Name changes are subject to penalties.

Please be advised, many airlines do not provide advance seat assignments until check-in at the airport. Advance seating will be subject to the airline's terms and conditions.

Prior to full payment for the program, the cruise line reserves the right to impose a supplemental fuel charge. Should this occur, you will be notified of the additional charges.

Taxes and fees starting from \$715 USD per person (subject to change without advance notice), quoted at time of booking, are payable at time of final payment. Single cabins, if confirmed, are higher.

Prepaid tipping is not available on our tours therefore payment of customary end-of-trip gratuities for your Tour Manager, driver, local guides, hotel housekeepers, and cruise ship waitstaff should be handled individually when applicable during the course of your tour.

Onboard gratuities are not included in the price of your tour. For your convenience, Holland America Cruise Lines automatically applies a \$17.00 USD (quoted at time of printing) per traveler per day service charge to your shipboard account.
